ACKNOWLEDGEMENT OF SATISFACTION OF SUBDIVISION IMPROVEMENTS AGREEMENT

WHEREAS, within thirty (30) days after the Developer has completed all of the public improvements required by the Subdivision Improvement Agreement and the work has been approved and accepted by the Town, the entire remaining amount of the security, less an amount equal to ten percent (10%) of the original amount of the security shall be released.

NOW THEREFORE, at the request of the Developer, the Town hereby acknowledges the satisfaction of the Subdivision Improvements Agreement entered into by the Developer and the Town for the Town Center Subdivision and hereby authorizes the release of the security from the above-identified Letter of Credit in the amount of \$96,930.00.
