**A RESOLUTION OF THE BOARD OF TRUSTEES OF THE TOWN OF CARBONDALE,  
COLORADO, SUPPORTING THE GRANT APPLICATION FOR A LOCAL GOVERNMENT  
MINI-GRANT FROM THE STATE BOARD OF THE GREAT OUTDOORS COLORADO FOR  
THE CONSTRUCTION OF THE YOUTH ART PARK ON THE RIO GRANDE ARTWAY**

**WHEREAS:** The Town of Carbondale supports the Great Outdoors Colorado grant application for the Youth Art Park on the Rio Grande ARTway Project, with project partners Roaring Fork Transportation Authority and Carbondale Arts.

**WHEREAS:** Great Outdoors Colorado requires that the Board of Trustees of the Town of Carbondale state its support for the Great Outdoors Colorado mini- grant application for completing the Youth Art Park at the Rio Grande ARTway. The Town of Carbondale has requested a total award of \$45,000.00 from Greater Outdoors Colorado; and


**NOW, THEREFORE BE IT HEREBY RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF CARBONDALE THAT:**

1. The above recitals are hereby incorporated as findings by the Board of Trustees of the Town of Carbondale.
2. The Board of Trustees of the Town of Carbondale strongly supports the Grant Application submitted by the Town of Carbondale for a grant with Great Outdoors Colorado.
3. If the grant is awarded, the Board of Trustees of the Town of Carbondale strongly supports the completion of a local government mini grant for the construction of a Youth Art Park for the Rio Grande ARTway Corridor project.
4. The Board of Trustees of the Town of Carbondale authorizes the expenditure of any funds necessary to meet the terms and obligations of a grant awarded pursuant to a Grant Agreement with Great Outdoors Colorado.
5. The Board of Trustees of the Town of Carbondale acknowledges that the grant application includes matching funds which Town of Carbondale and /or partners bear the responsibility to provide if a grant is awarded.
6. If a grant is awarded, the Board of Trustees of the Town of Carbondale hereby authorizes the Mayor to sign a Grant Agreement with Great Outdoor Colorado.
